Plan Revisions Summary Narrative

Birthplace

- Removed existing windows between the nursery and nurse station.
- Added upper cabinets where windows were removed for additional storage at the nurse station.
- Added a second window from nurse station to the west hallway.
- Double doors between MSU and Birthplace moved north towards the nurse station.

Procedure

- Flipped the patient entrance/exit to align with the waiting area to the west.
- Added a storage alcove near the waiting room entrance.
- Revised central staff support core to include the following
 - Improved visibility of nurse stations to the rooms.
 - Maintained central clean/med room between nurse stations.
 - Revised the soiled room access to be off the hall and not through the nurse station.
- Refined northeast corner of the east nurse station for easier hallway movement around the existing structural brace frame.
- Moved Dustys office away from the nurse station to the northeast corner (adjacent to registration office).
- Added double doors to the south (near patient room 10).
- Connected storage and clean storage around OR 5.
- Added 4' door to clean storage from south hallway for equipment storage and material supply access.
- Moved Pathology room across from the Endo EVS room.
- Closed off the Endo hallway from the sterile core corridor and moved Endo dictation to the east for clear access to both Endo procedure rooms.

- Increased the size of the north storage room.
- Moved offices together and created a larger office for anesthesia.
- Reduced the size of dictation.
- Relocated the required PACU staff restroom to be accessed from clean/med nurse station.
- Moved A.I.I. anteroom to the north.
- Added additional space to the north of PACU for storage.
- Created a separate EVS room near central sterile with access from the sterile hall.
- Added a separate endo storage room near the endo/procedure rooms.
- Moved handwashing sink in PACU to be central to PACU bays.
- Increased sterilizer room to accommodate existing sterilizers clearances and centered the 4' door into the space.

Central Sterile

- Flipped decontamination and clean sides of central sterile.
- Moved drop off/pick up room between the clean and dirty sides.
- Added door from hallway into decontamination.

Registration

- Main Entry
 - Reduced the number of offices to two for front registration area.
 - Moved the east waiting space in the front gallery closer to registration.
- Emergency Entry
 - Removed the wall and door between the security space and registration.
 - Revised security desk to a straight run aligned with back registration counter.
 - Removed the existing fire exit door to the outside in the waiting room.

Imaging

- The tech work room has flipped with blood draw.
- Patient entrance into imaging department is separate from other departments.

Lab

- Revised blood draw area to include separate entry from the front waiting area.
- Revised the hallway door into the main lab to a 4' door.
- Additional lockers were added to the breakroom to accommodate 10 double lockers (20 total lockers).
- Relocated handwashing sink related to the larger hallway door opening.
- Switched locations of computer and blood culture in microbiology.
- Removed second access from chemistry bench.

Care Coordination & Nutrition

• Added an office for 3 people and a printer with windows for natural daylight.

Emergency

- Revised the door into the department from the waiting room to 4' and made the access route to the ED hallway larger.
- Revised the south rooms to two new trauma rooms.
- Moved the soiled room for patient restrooms on opposite sides.
- Revised the new EVS room to an office.
- DOH Review comment- Changed one patient restroom into Individual of Size (IOS) restroom across from the IOS trauma room.
- DOH Review comment- Created an open nurse/EMS workstation with direct visual connection to the A.I.I. Room.

Respiratory

• Added respiratory office next to the new chapel location near the birthplace entry.

Other Updates

- Relocated Chapel to be accessed from front gallery space.
- An additional restroom was added in the northeast corner near birthplace.
- Revised second floor EVS & I.T. room locations.
- New AHU/I.T. space shown on second floor, in existing Skills Lab space.
- Removed the east hallway next to the second floor shell space for expanded storage space.
